Witness Fees (computation, cf. 28 U.S.C. § 1821 for statutory fees)

Section 1924, Title 28, U.S. Code (effective September 1, 1948) provides:

“Before any bill of costs is taxed, the party claiming any item of cost or disbursement shall attach thereto an affidavit, made by himself or by his duly authorized attorney or agent having knowledge of the facts, that such item is correct and has been necessarily incurred in the case and that the services for which fees have been charged were actually and necessarily performed.”

“A bill of costs shall be filed in the case and, upon allowance, included in the judgment or decree.”

RULE 54(d)(1)

Unless a federal statute, these rules, or a court order provides otherwise, costs — other than attorney’s fees — should be allowed to the prevailing party. But costs against the United States, its officers, and its agencies may be imposed only to the extent allowed by law. The clerk may tax costs on 14 days’ notice. On motion served within the next 7 days, the court may review the clerk’s action.

(d) **Additional Time After Certain Kinds of Service.** When a party may or must act within a specified time after being served and service is made under Rule 5(b)(2)(C) (mail), (D) (leaving with the clerk), or (F) (other means consented to), 3 days are added after the period would otherwise expire under Rule 6(a).

Ordinarily, the entry of judgment may not be delayed, nor the time for appeal extended, in order to tax costs or award fees. But if a timely motion for attorney's fees is made under Rule 54(d)(2), the court may act before a notice of appeal has been filed and become effective to order that the motion have the same effect under Federal Rule of Appellate Procedure 4(a)(4) as a timely motion under Rule 59.

AFFIDAVIT IN SUPPORT OF BILL OF COSTS

I, Rees F. Morgan, having been sworn under oath, do depose and state as follows:

1. I am an attorney duly admitted to practice before this Court. I am a partner of Coblentz Patch Duffy & Bass LLP, attorneys of record for Defendants DraftKings Inc. and Crown IA Gaming LLC d/b/a DraftKings (collectively, "DraftKings") in this matter. I make this declaration based on my personal knowledge and review of materials in this case. If called as a witness, I could and would testify competently to the matters set forth herein.

2. On July 8, 2026, the Court entered its order granting summary judgment in favor of DraftKings. ECF No. 149. Judgment was entered the following day. ECF No. 151.

3. I submit this affidavit in support of DraftKings' Bill of Costs. Pursuant to 28 U.S. Code section 1920, filing fees, deposition transcript and court reporter costs, hearing transcripts, and exemplification costs are taxable.

4. Deposition related costs are taxable if "submitted in connection with an event that

terminated the litigation” or the transcript was necessarily obtained. *Bill of Costs Guidelines*, S.D. Iowa, p. 5 (August 2017). The underlying question simply “is whether the depositions reasonably seemed necessary at the time they were taken.” *Zotos v. Lindbergh Sch. Dist.*, 121 F.3d 356, 363 (8th Cir. 1997) (quoting omitted). Even when the transcript is not used at trial or summary judgment, deposition costs are taxable if “necessarily obtained for use in [a] case and was not purely investigative.” *Smith v. Tenet Healthsystem SL, Inc.*, 436 F.3d 879, 889 (8th Cir. 2006) (quoting omitted) (alterations in original). Deposition video costs, for example, are taxable for cases resolved at summary judgment when the credibility of the witness “would have been a critical issue at trial.” *Barcomb v. Gen. Motors LLC*, 978 F.3d 545, 551 (8th Cir. 2020). When a deposition is taxable, the related costs (fees, exhibit copies, etc.) are taxable as well. *See, e.g., Smith v. Toyota Motor Corp.*, No. 2:16CV24 ERW, 2018 WL 3496491, at *3 (E.D. Mo. July 20, 2018) (“[C]osts for copies of deposition exhibits are recoverable to the same extent as their corresponding depositions.” (quoting omitted)); *Jet Midwest Int’l Co. v. Jet Midwest Grp., LLC*, 93 F.4th 408, 423 (8th Cir. 2024) (“It is generally recognized that the basic costs of an original deposition transcript and one copy are taxable against the non-prevailing party.” (quoting omitted)).

5. To support the Bill of Costs, I have attached true and accurate copies of the Court’s Docket for Court filing fee related expenses as **Exhibit A**, additional supporting documents for Court filing fee related expenses as **Exhibit B**, invoices for deposition and hearing transcript related expenses as **Exhibit C**, invoices for printing copies for depositions as **Exhibit D**, and invoices for printing courtesy copies for the Court as **Exhibit E**.

6. DraftKings respectfully requests that the clerk prepare and tax an itemized statement of costs for a total of **\$23,502.80**, as set out below. *Thompson v. Wal Mart Stores, Inc.*,

472 F.3d 515, 517 (8th Cir. 2006) (“A prevailing party is presumptively entitled to recover all of its costs.” (quoting omitted)).

7. The items in DraftKings’ Bill of Costs are correct, the services included therein were actually and necessarily performed, and the disbursements were actually and necessarily incurred in this action.

8. The filing fees paid for the *Pro Hac Vice* applications for the attorneys from my firm in this action is a total of \$600.00. A true and correct copy of the Court’s Docket reflecting the filing fees and record of payment is attached hereto as **Exhibit A**.

9. The filing fees paid in response to Plaintiff’s Summons and Complaint were \$405.00. A true and correct copy of Belin McCormick P.C.’s invoice, dated July 1, 2025, indicating the payment made to the court on June 20, 2025 is attached hereto as **Exhibit B**.

10. On January 30, 2026, Plaintiff took the deposition of Tom Butterworth, as the Rule 30(b)(6) representative for DraftKings. DraftKings paid Esquire Deposition Solutions \$2,218.55 for an electronic copy of the original transcript of the deposition, and \$640.00 for the video of the deposition. Mr. Butterworth’s testimony was reasonably necessary to DraftKings’ defense in the case, including to its defenses under the applicable Terms of Use and House Rules, and affirmative defenses. Video of the deposition was reasonably necessary in case the witness was unavailable to testify at trial. Plaintiff and DraftKings relied on Mr. Butterworth’s deposition testimony in support of their respective summary judgment motions. DraftKings’ summary judgment motion resulted in disposition of this matter with DraftKings as the prevailing party. True and correct copies of the Esquire Deposition Solutions invoices, dated February 11, 2026 and February 13, 2026, are attached hereto as **Exhibit C**.

11. On February 17, 2026, Plaintiff took the deposition of Stephen Baumohl. DraftKings paid Susan Frye Court Reporting \$1,132.75 for an electronic copy of the original transcript of the deposition. Mr. Baumohl's testimony was reasonably necessary to DraftKings' defense in the case, including to its defenses under the applicable Terms of Use and House Rules, and affirmative defenses. Plaintiff and DraftKings relied on Mr. Baumohl's deposition testimony in support of their respective summary judgment motions. DraftKings' summary judgment motion resulted in disposition of this matter with DraftKings as the prevailing party. A true and correct copy of the Susan Frye Court Reporting invoice, dated February 26, 2026, is attached hereto as **Exhibit C**.

12. On March 6, 2026, DraftKings took the deposition of Plaintiff Nicholas Bavas. DraftKings paid Barkley Court Reporters \$3,025.20 for an electronic copy of the original transcript of the deposition, and \$1,885.00 for the video of the deposition. Mr. Bavas's testimony was reasonably necessary to DraftKings' defense in the case, including to its defenses under the applicable Terms of Use and House Rules, and affirmative defenses. Video of the deposition was reasonably necessary in case the witness was unavailable to testify at trial and/or needed to assess the credibility of the witness. DraftKings relied on Mr. Bavas's deposition testimony in support of their summary judgment motion. DraftKings' summary judgment motion resulted in disposition of this matter with DraftKings as the prevailing party. True and correct copies of the Barkley Court Reporters invoices, dated March 24, 2026 and March 31, 2026, are attached hereto as **Exhibit C**.

13. On March 11, 2026, Plaintiff took the deposition of Terry Pattinson, as Expert Witness for DraftKings. DraftKings paid Susan Frye Court Reporting \$891.00 for an electronic copy of the original transcript of the deposition. Mr. Pattinson's testimony was reasonably necessary to DraftKings' defense in the case, including to its defenses under the applicable Terms

of Use and House Rules, and affirmative defenses. DraftKings relied on Mr. Pattinson's deposition testimony in support of their summary judgment motion. DraftKings' summary judgment motion resulted in disposition of this matter with DraftKings as the prevailing party. A true and correct copy of the Susan Frye Court Reporting invoice, dated March 26, 2026, is attached hereto as **Exhibit C**.

14. On March 13, 2026, DraftKings took the deposition of Gerard Wixted. DraftKings paid Barkley Court Reporters \$1,992.45 for an electronic copy of the original transcript of the deposition, and \$715.00 for the video of the deposition. Mr. Wixted's testimony was reasonably necessary to DraftKings' defense in the case, including to its defenses under the applicable Terms of Use and House Rules, and affirmative defenses. Video of the deposition was reasonably necessary in case the witness was unavailable to testify at trial and/or needed to assess the credibility of the witness. Mr. Wixted is not located in Iowa and would be beyond the subpoena power of this Court if he needed to be called as a witness. Fed. R. Civ. P. 45. DraftKings relied on Mr. Wixted's deposition testimony in support of their summary judgment motion. DraftKings' summary judgment motion resulted in disposition of this matter with DraftKings as the prevailing party. True and correct copies of the Barkley Court Reporters invoices, dated March 18, 2026 and March 24, 2026, are attached hereto as **Exhibit C**.

15. On March 17, 2026, Plaintiff took the deposition of Keir Adams. DraftKings paid Susan Frye Court Reporting \$1,740.15 for an electronic copy of the original transcript of the deposition. Mr. Adams' testimony was reasonably necessary to DraftKings' defense in the case, including to its defenses under the applicable Terms of Use and House Rules, and affirmative defenses. Plaintiff and DraftKings relied on Mr. Adams' deposition testimony in support of their respective summary judgment motions. DraftKings' summary judgment motion resulted in

disposition of this matter with DraftKings as the prevailing party. A true and correct copy of the Susan Frye Court Reporting invoice, dated March 26, 2026, is attached hereto as **Exhibit C**.

16. On March 18, 2026, DraftKings took the deposition of Daniel Hurst. DraftKings paid Barkley Court Reporters \$1,178.10 for an electronic copy of the original transcript of the deposition, and \$680.00 for the video of the deposition. Mr. Hurst's testimony was reasonably necessary to DraftKings' defense in the case, including to its defenses under the applicable Terms of Use and House Rules, and affirmative defenses. Video of the deposition was reasonably necessary in case the witness was unavailable to testify at trial and/or needed to assess the credibility of the witness. Mr. Hurst is not located in Iowa and would be beyond the subpoena power of this Court if he needed to be called as a witness. Fed. R. Civ. P. 45. DraftKings relied on Mr. Hurst's deposition testimony in support of their summary judgment motion. DraftKings' summary judgment motion resulted in disposition of this matter with DraftKings as the prevailing party. True and correct copies of the Barkley Court Reporters invoices, dated March 25, 2026 and March 31, 2026, are attached hereto as **Exhibit C**.

17. On March 19, 2026, Plaintiff took the deposition of Jacob List. DraftKings paid Susan Frye Court Reporting \$1,078.85 for an electronic copy of the original transcript of the deposition. Mr. List's testimony was reasonably necessary to DraftKings' defense in the case, including to its defenses under the applicable Terms of Use and House Rules, and affirmative defenses. Plaintiff and Defendants relied on Mr. List's deposition testimony in support of their respective summary judgment motions. DraftKings' summary judgment motion resulted in disposition of this matter with DraftKings as the prevailing party. A true and correct copy of the Susan Frye Court Reporting invoice, dated March 26, 2026, is attached hereto as **Exhibit C**.

18. On March 27, 2026, DraftKings took the deposition of Brandon Mastromartino, Ph.D. DraftKings paid Barkley Court Reporters \$2,240.45 for an electronic copy of the original transcript of the deposition, and \$1,171.25 for the video of the deposition. Dr. Mastromartino is not located in Iowa and would be beyond the subpoena power of this Court if he needed to be called as a witness. Fed. R. Civ. P. 45. Dr. Mastromartino's testimony was reasonably necessary to DraftKings' defense in the case, as Plaintiff had disclosed Dr. Mastromartino as an expert witness. True and correct copies of the Barkley Court Reporters invoices, dated April 3, 2026 and April 6, 2026, are attached hereto as **Exhibit C**.

19. On April 1, 2026, Plaintiff took the deposition of Gregory Karamitis. DraftKings paid Susan Frye Court Reporting \$1,074.50 for an electronic copy of the original transcript of the deposition. Mr. Karamitis's testimony was reasonably necessary to DraftKings' defense in the case, including to its defenses under the applicable Terms of Use and House Rules, and affirmative defenses. Plaintiffs and Defendants relied on Mr. Karamitis's deposition testimony in support of their respective summary judgment motions. DraftKings' summary judgment motion resulted in disposition of this matter with DraftKings as the prevailing party. A true and correct copy of the Susan Frye Court Reporting invoice, dated April 7, 2026, is attached hereto as **Exhibit C**.

20. On June 18, 2026, the Court held a hearing on the parties' Cross-Motions for Summary Judgment, wherein Tonya R. Gerke was the presiding court reporter. DraftKings paid Tonya R. Gerke \$374.40 for an electronic copy of the original transcript of the hearing. The transcript for the hearing was reasonably necessary to DraftKings' defense in the case as the summary judgment motion and subsequent hearing resulted in disposition of this matter with DraftKings as the prevailing party. A true and correct copy of Belin McCormick P.C.'s invoice, dated July 1, 2026, reflecting the amount is attached hereto as **Exhibit C**.

21. The printing costs for documents and exhibits used in connection with Mr. Mastromartino's deposition were \$238.75. A true and correct copy of Express Network Invoice No. SF-26-81195, dated March 31, 2026, reflecting the total printing costs (\$238.75) for deposition testimony is attached hereto as **Exhibit D**.

22. The total copying costs incurred for submitting courtesy copies for moving papers, declarations and exhibits submitted in support of DraftKings' Motion for Summary Judgment was \$221.40. A true and correct copy of Belin McCormick P.C.'s invoice, dated June 1, 2026, reflecting the amount is attached hereto as **Exhibit E**.

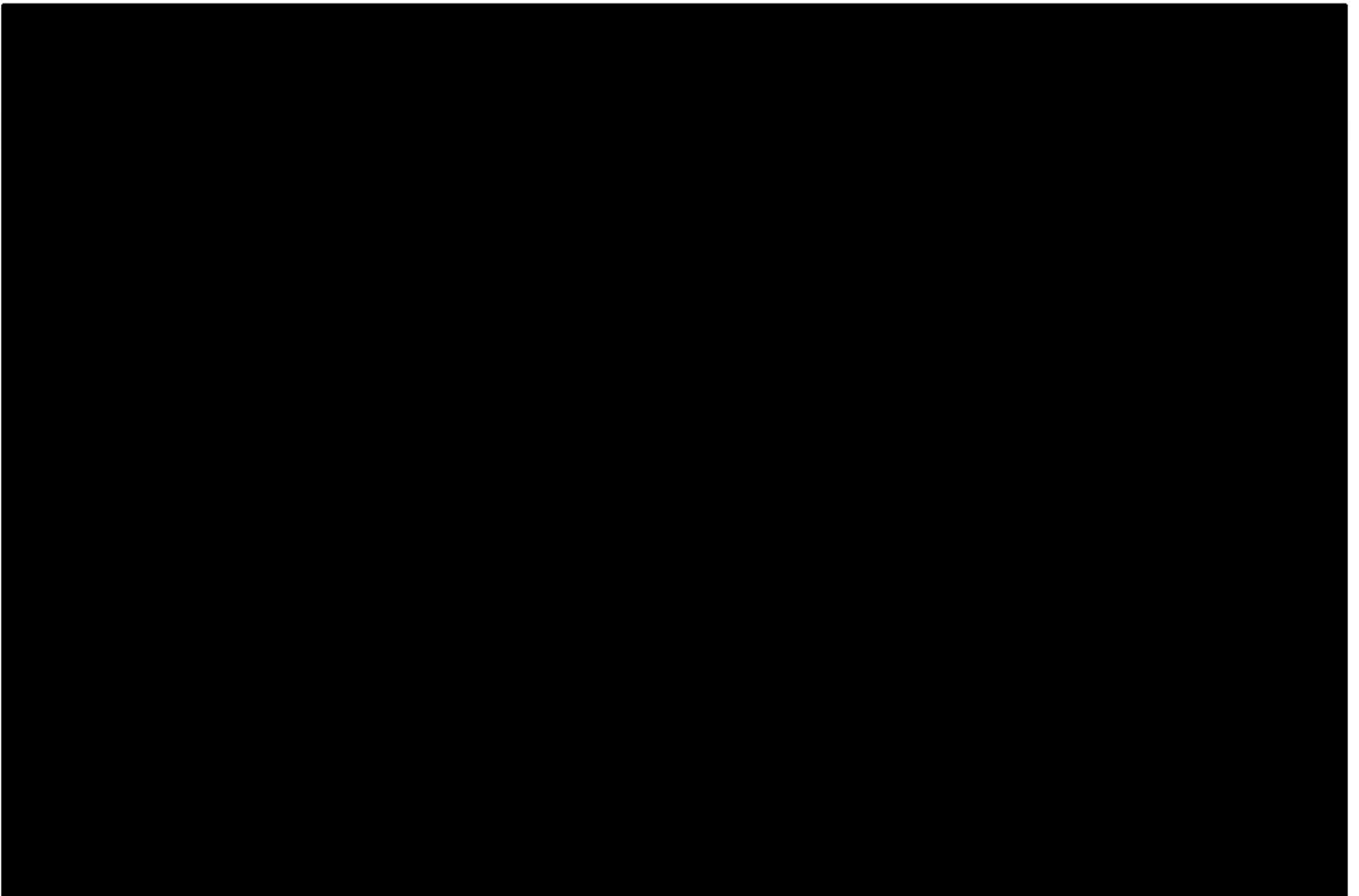

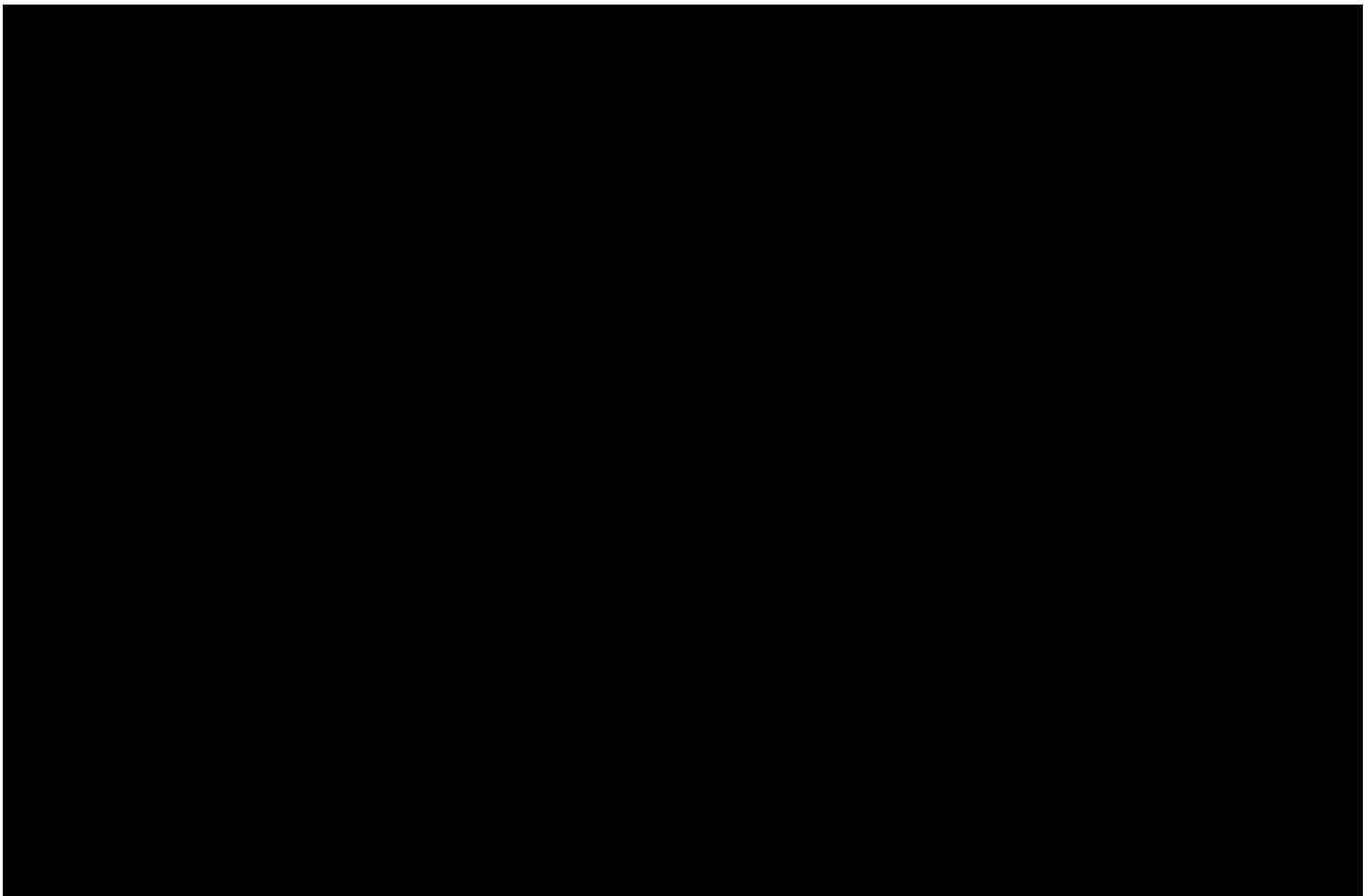
